Celia Scott-Silkwood, of the Northwest Arkansas Regional Planning Commission presented information regarding how to develop a Master Trail Plan for the City of Farmington.

- 1) Commissioners should identify goals of a trails system, with input from citizens.
- 2) Brainstorm and mark trail ideas on map, taking into consideration where existing trails are located, where Fayetteville trails are located that might be connected with, types of trails desired—Bike? Hiking? Trail-bike? Should trails connect to schools? workplaces and local businesses? Non-motorized trails must be a minimum of 12 feet.
- 3) Put a questionnaire for public's input on the City of Farmington website. Documented input from the public will be important; also keep careful notes of public meetings where input was offered.
- 4) Put together the final plan.
- 5) Change ordinances related to land development, including trail requirements in the plats.
- 6) Search out funding resources: Federal and state funding; foundations, environmental groups, private donors. If the Master Trial Plan could integrate into the NWARPC Long Range Plan, that might also private some funding.
- 7) Buy land easements needed. Often costs can be reduced when trails are put by historical sites, in flood plains, in parks, on utility easements, or tie into other established trails, and connect to schools.
